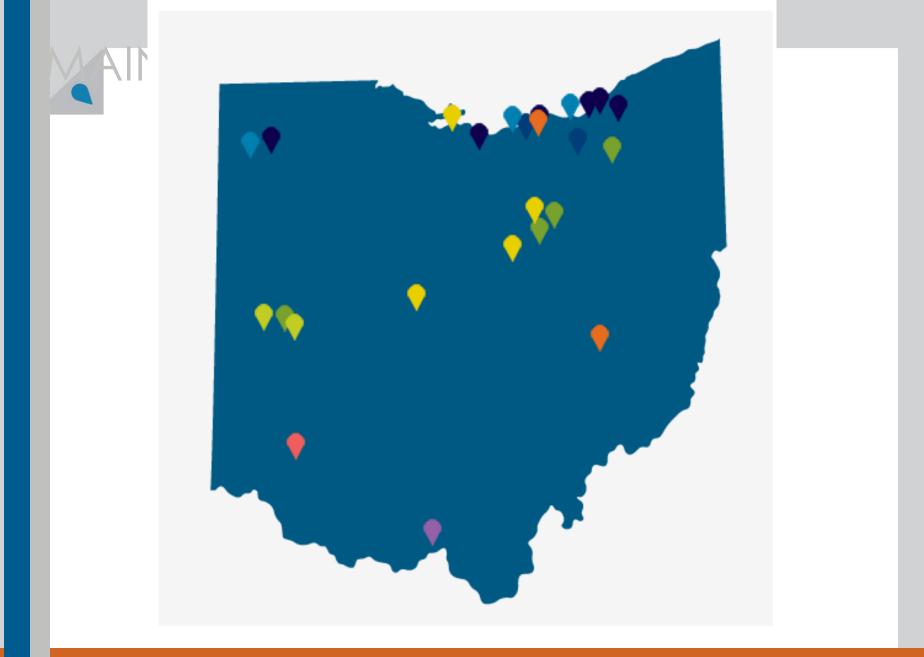

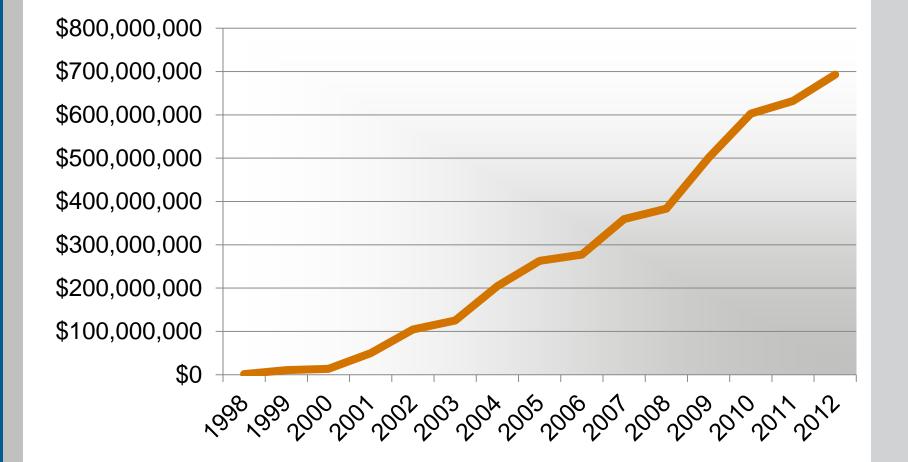

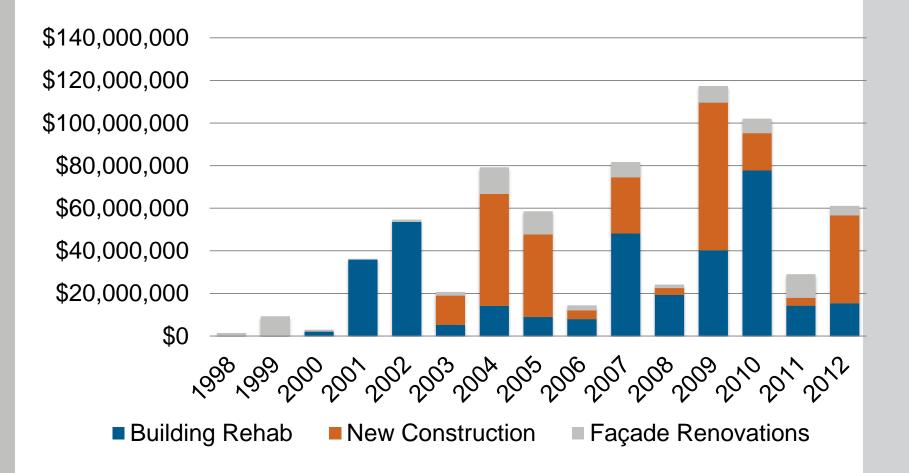

REINVESTMENT STATISTICS CUMULATI

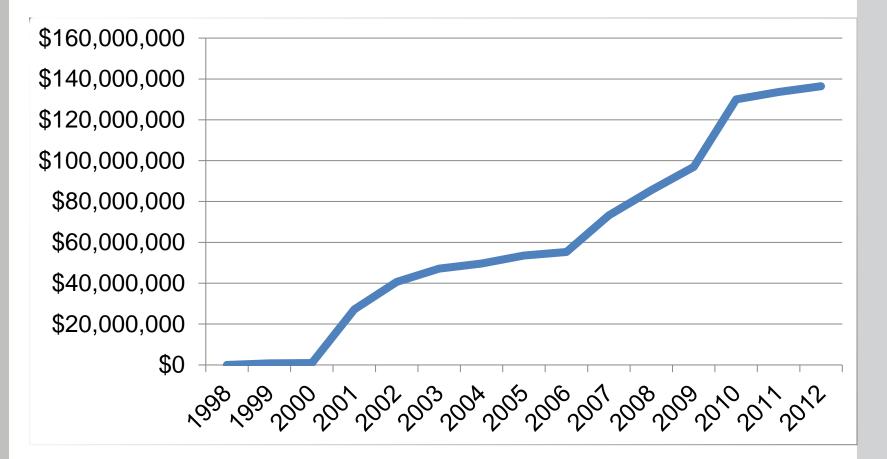


CUMULATIVE PRIVATE INVESTMENT

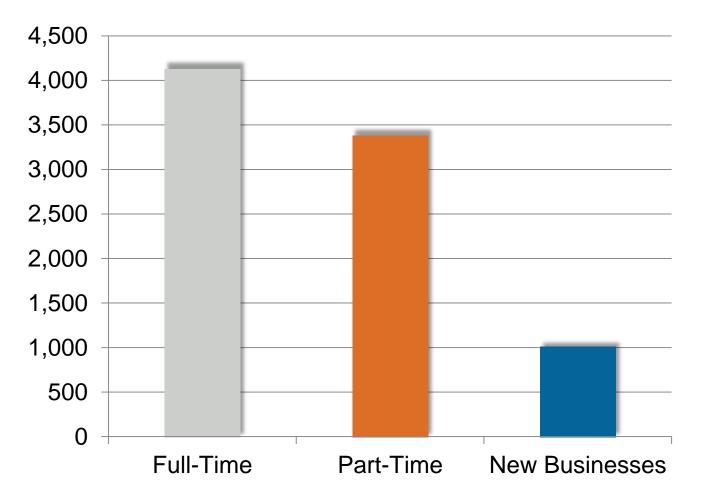
BREAKDOWN OF PRIVATE INVESTMENT
