### A Year of Webinars!

In a typical year, Heritage Ohio would make at least 16 visits around the state helping to introduce building owners and officials on how to use historic tax credits to revitalize their buildings and communities. In the absence of travel—we hosted webinars: in April Historic Tax Credits 101 and Historic Tax Credits 201 had 213 people attend live. We hosted three webinars on understanding the Secretary of Interiors Guidelines for Rehabilitation. As part of our Annual Conference, we hosted several more sessions on using historic tax credits. ### WHAT WE LEARNED IN 2020

#### A Year to Remember

At Heritage Ohio, we worked harder than ever to move the ball forward during an extraordinary year. Main Street is resilient and the right program to help in the Economic Vitality of their downtowns. The boards and managers took on projects that would help sustain the local businesses and provide resources and entertainment for the local community. Investing locally means more than shopping.

Over **3500** participants attended our programs; virtual programs allowed so many more people to join in on our offerings.

### 2020 REVITALIZATION

#### Tiny Investment with a Big Impact!

We are so happy to share that Heritage Ohio received a \$500,000 appropriation in the biennial budget 2019-2021. This appropriation established a small grant program for building improvements in Ohio Main Street Communities. Each Main Street community program applied for \$20,000 to help buildings and or business owners with small building improvements including but not limited to: the exterior, including roofs, masonry repair, or signage; tenant improvements on the interior or patio build outs; or upper floor housing improvements. Though many projects have yet to be completed in 2021, we have been able to fund 141 projects: the realized leveraged numbers currently running \$1: \$1.6. Small projects were funded which have no support system from other funding sources, yet have

economic impact and help revitalize the historic downtown district. With the pandemic hitting in 2020, these grants made even more of an impact to the businesses, communities, and people of the Main Street cities.

#### OHIO MAIN STREET STATISTICS

2020 was a challenging year for so many businesses. Many rehabilitation projects were underway, were completed, and many planning to start were sidelined. Even during the pandemic, the entrepreneurial spirit prevails.

There are a few bright spots of new business opening. 95 building rehabilitations with investment of \$199,239,963 New Housing Units Completed: 348 New business opened: 117 Businesses closed: 84 Net full time jobs: +38 Net part time jobs: -160 Facade Rehabilitations: 110 Total Public & Private Investment in Downtown: \$207,657,857

### THE OHIO MAIN STREET PROGRAM

The National Main Street Center was formed in 1980, and Heritage Ohio became the coordinating agency for Ohio in 1997. Currently there are 22 programs enrolled in the program. The Ohio Main Street Program is local grassroots driven revitalization program, led by a local Board of Trustees which employs a professional executive director. These programs are accountable through an annual evaluation process to receive National Accreditation. Enrollment fee is \$3,950/year.

### **2020 PRESERVATION**

#### Paul Bruhn NPS Grant of \$556,327 Award!

In 2020, Heritage Ohio partnered with Ohio History Connection to apply for funding through the Paul Bruhn Historic Revitalization Grants Program administered by the National Park Service. We were thrilled to learn in August that our application had been approved! In 2021, we'll be re-granting funds to National Register-listed buildings in Main Street communities through a competitive application process. Stay tuned as these funds assist small-scale building owners with needed brick and mortar funding.

#### Heritage Ohio holds 16 easements across the state.

Easements protect the historic character of a building in perpetuity. A formal agreement is made between the building owner and Heritage Ohio which becomes part of the deed record for the property.

Heritage Ohio conducts annual inspections to ensure continued building preservation. Easements can include important interior spaces.

Owners who gift easements to Heritage Ohio may qualify for a tax deduction.

### 2020 ADVOCACY

One of the most important roles Heritage Ohio plays is building and maintaining relationships with elected officials, making sure they know how various preservation programs work to save the places that matter.

#### **Statehood Day**

Statehood Day took place February 26, 2020. Heritage Ohio paired up with the State Historic Preservation Office for a team of 13 to make visits to 23 state legislative offices, promoting the success of the Ohio Historic Preservation Tax Credit; advocating for protecting human burial places; and Poindexter Village to be designated as a historic site. We were honored to recognize the important work State Senator Tim Schaffer has done for Appalachia, historic preservation and Ohio Main Street communities, by


conferring the Heritage Award.
